

Taxes paid

The taxes we pay in Canada and around the world are another measure of the way Sun Life Financial contributes to the economies and societies in which we live, work and do business.

In 2010, in all jurisdictions where the Company operates, tax expenses to governments totalled \$644 million. Of this total, \$165 million was paid in income taxes, \$1 million was paid in capital taxes, \$185 million was paid in premium taxes and \$293 million was paid in excise, property and payroll taxes. In Canada, the Company's total tax expenses for 2010 were \$314 million.
