The following information must be provided to ensure the proper administration of taxes in connection with the Contract Holder's benefits plan(s) with Sun Life Assurance Company of Canada.

Part A - Ontario Retail Sales Tax (RST) - For all Contract Holders with employees in Ontario

### Ontario Retail Sales Tax (RST)

To be completed by all Contract Holders with employees in Ontario

Ontario Retail Sales Tax (RST) - Remittance Election Form

Under the Ontario Retail Sales Tax Act, employers are required to remit, directly to the Ministry of Finance, the Ontario Retail Sales Tax (RST) collected on their members' contributions to the benefits plan if the members are Ontario residents, unless:

- 1. The employer is not a registered vendor, or
- 2. The employer specifically elects to send the RST to the insurer for payment to the Ministry of Finance. For ease of retail sales tax administration and reconciliation, it is Sun Life Assurance Company of Canada's standard approach to collect and remit the full retail sales tax amount on behalf of Contract Holders. This form is the Contract Holder's certification confirming this approach.

## A Ontario Retail Sales Tax (RST) (continued)

The Contract Holder claims exemption from Ontario Retail Sales Tax, under the provisions of the Ontario Retail Sales Tax Act, on the contract(s) listed above. Group Benefits under the above contract(s) are exempt from Ontario Retail Sales Tax for the following:

- · Members who ordinarily work outside Ontario or whose salary is ordinarily paid outside Ontario
- Contributions paid by members who are not ordinarily residents of Ontario

- · Status Indians resident on a reserve
